As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you'll find the tools you need for managing users, your group, and your group trunk groups on the IP Flexible Reach Customer Portal. To access the Customer Portal, you must first log in to Premier.

Log In the First Time

An Enterprise Administrator in your organization will create a Premier account for you. You'll receive an email telling you that a Premier login has been created for you. You'll receive a second email containing your temporary password.

To activate a Premier account created for you

1. Open either the confirmation email or the password email. (The **Login** link appears in both.)
2. Click **Login** or copy and paste the login URL in the email into a browser. The Premier Log In page appears.
3. Enter your username from the email.
4. Enter your temporary password from the second email.
5. Click **Log In**.

After you've logged in, change your password and set your two Secret Questions and Secret Answers. You'll also be asked to enter profile information. You can then access the Customer Portal.

Log In to Premier

To access the Customer Portal, you must always first [log in to Premier](#).

To log in to Premier

1. Open the Premier home page.
2. Enter your username and password.
3. Click **Log In**. The Premier home page appears.

Note: To recover a password, Premier now requires answers to two Secret Questions. If you entered only one Secret Question/Secret Answer when you originally registered with Premier, set up a second Secret Question/Secret Answer in your Premier profile now.

When you click **Log In**, the Update My Login Profile page appears. In the **Setup Second Security Question** window that opens, enter an additional Secret Question and Secret Answer, and then click **Continue**. (To proceed to the Premier home page without updating your profile, click **Not Now**. You



can log in three times and select **Not Now** before you must set up your second Secret Question/Secret Answer.)

If Two-Step Login is turned on, all users in your enterprise must enter their username and password and then answer one of their secret questions in order to log in to Premier.

Access the Customer Portal

After you've logged in to Premier, you can access the Customer Portal.

To access the Customer Portal

In the AT&T IP Flexible Reach Quick Links tile of the Premier home page, click **View AT&T IP Flexible Reach Customer Portal home**. The Customer Portal appears.

Recover Your Premier Username or Password

You can easily recover your Premier username or password from the Premier Log In page.

To recover a forgotten username or password

1. To recover your information, go to the [Premier Log In](#) page.
2. To recover your username, under **Login Help**, click **Forgot your username?** And follow the instructions to recover your username.
3. To recover your password, under **Login Help**, click **Forgot your password?** and follow the instructions to reset your password.

If You Were Assigned Two or More Premier Logins

If you're a Group Administrator for more than one group, you may have two or more Premier logins. However, you can't be logged in to Premier with more than one username at a time using the same browser. This means that within your browser, you must sign out of one Premier ID before logging in with another.

If you want to use multiple Premier IDs at one time, you must use different browsers (not just separate windows or tabs). For example, you would need to use Internet Explorer® and Chrome™, or Chrome and Firefox®, or two other browsers.

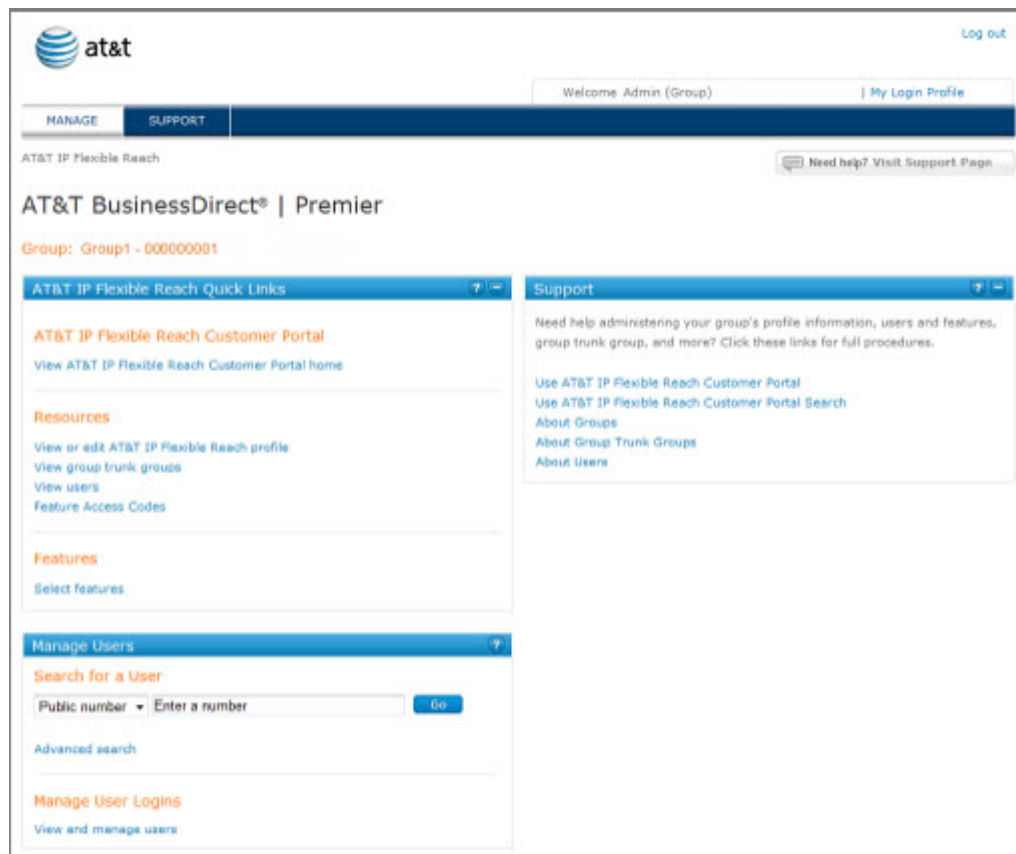

Premier Home Page

To use Premier, [log in](#). When you log in, the Premier home page appears.





Navigation

From the Premier home page, you can quickly access the Customer Portal, manage your groups, view messages, and get support information.

At the top of the page you'll see **MANAGE** and **SUPPORT**. You can access the Customer Portal by clicking links on the **MANAGE** view of the Premier home page.

Note: The Premier home page opens in **MANAGE** view.

- To view a list of help topics to get you started and help you perform tasks, click **SUPPORT**.
- To view and edit your login profile, click **My Login Profile** at the upper-right of the page.
- To exit Premier, click **Log out** at the upper-right of the page.

AT&T IP Flexible Reach Quick Links

To view results

The results of your search appear below **Search Results**, and show the user's first and last name, public number, extension, and group name and group ID.

- To view and edit the user's calling features, click **Features**.
- To view the user's logged calls, click **Call Logs**.
- To view and edit the user's profile, click **Profile**.

To manage user logins

- To see and manage a user's login information, under **Manage User Logins**, click **View and manage users**.

Messages

The **Messages** tile links you to your messages.

Note: The **Messages** tile appears only if you have messages waiting for you.

To view messages

Messages appear at the right of the Information icon .

- To see all your messages, click **View all messages**.

AT&T IP Flexible Reach is a trunking service that delivers an integrated access solution for the following environments:

- Time Division Multiplexing Private Branch Exchanges (TDM PBX)
- Internet Protocol Private Branch (IP PBX)
- Key analog systems

IP Flexible Reach can operate with the session initiation protocol (SIP), supporting inbound and outbound calling across the AT&T Internet Protocol (IP) network. It takes advantage of the AT&T Global Multiprotocol Label Switching (MPLS) network to provide local, nationwide, and international long distance reach for U.S. sites.

AT&T provides Enhanced IP Flexible Reach Group Administrators with a portal for managing functions and features.

Customer Portal

The Customer Portal is the central place from where you can manage your group, group departments, group trunk group, users, and more.

To access the Customer Portal, first [log in](#) to Premier. On the Premier homepage, click **View AT&T IP Flexible Reach Customer Portal home**. The Customer Portal opens.



Navigation

To go to a specific page where you can manage resources, administrators, or users, click a tab on the menu bar at the top of the Customer Portal.

- To view group information and to manage your group, click **RESOURCES**. The Group page appears.
- To search for and view administrators, click **ADMINISTRATORS**. The Administrators page appears.
- To search for and manage users, click **USER MANAGEMENT**. The Users page appears.
- To go to the Premier home page, click **Premier Home** at the upper-right of the page.
- To get help from an Enterprise Administrator, click **Contact Us**, which takes you to the Enterprise Contacts page.
- To get support, click **Support**, which takes you to the Administrative Portal Help page.

Directory Number Search

To search for a specific number

1. In the Search box under **Directory Number Search**, enter a public number.
2. Click **Go**. The results appear on the User page.

To search for a range of public numbers

1. In the search boxes under **Search Range** in the **Directory Number Search** tile, enter a range of public numbers.
2. Click **Go**. The results appear on the User List page.

To search for a range of extensions

1. In the search boxes under **Search Range** in the **Directory Number Search** tile, enter a range of extensions.
2. Click **Go**. The results appear on the User List page.

To view all numbers

At the top of the **Directory Number Search** tile, click **View all Numbers**. The main Users page appears.

Department Search

Use the **Department Search** tile on the Customer Portal Home page to view all departments or search for a specific department.

To search for a department

1. In the search box in the **Department Search** tile, enter a department name.
2. Click **Go**. Results appear on the Department List page.

To view all departments

- To view all group departments, in the **Department Search** tile, click **View all Group Departments**.

To use Quick Links

- At the upper-right of the page under **Quick Links**, click **View enterprise contact**.


Search Tools in the Customer Portal

You'll find two kinds of search tools throughout the Customer Portal: standard search tools and single field search tools.

Standard Search Tools

Standard search tools appear on most list pages throughout the Customer Portal; for example, on the [Users List](#) page.

If a search tool isn't open, click the arrow . The tool opens.

The standard search tool has three fields or drop-down lists.



- The left drop-down list contains a search option, such as **Last Name**, **First Name**, or **Public Number**.
- The middle drop-down list consists of search modifiers, such as **Starts With**, **Contains**, or **Equal To**.
- The field or drop-down list at the right is for your search term.

Notice the plus sign (+) or minus sign (-) to the right of each search row.

- To add rows, click the plus sign .
- To remove rows, click the minus sign .

To use the standard search tool

These are general instructions for using the Customer Portal search tools. The specifics vary between pages.

1. From the left drop-down list, select a search term.
2. From the middle drop-down list, select a search modifier.
3. In the search field at the right, enter a search value, or select a search value from the drop-down list as appropriate.
4. Click **Search**. The search results are displayed. The search result set can contain up to 1,000 records. If there are more than 1,000 records in the search results, refine your search to narrow the results.
 - To add search criteria, click the plus sign .
 - To remove search criteria, click the minus sign .

Single Field Tools

Use single field search tools when you know the exact information you're searching for, such as a specific phone number or a user's name.

To use the single field search tool

1. In the **Search** field, enter a value.
2. Click **Go**.

Search from the Customer Portal Homepage

From the Customer Portal Homepage, you can search for departments, telephone numbers, and extensions.

Search for Departments

Use the **Department Search** tile on the Customer Portal homepage to search for specific departments by name.

To search for a department

1. In the search box in the **Department Search** tile, enter a department name.
2. Click **Go**. Results appear on the Department List page.
3. From this tile you can also go directly to the Department List page, where you can see, search for, and edit departments. Click **View all Group Departments**.

Search for Directory Numbers

Use the **Directory Number Search** tile on the Customer Portal homepage to view all telephone numbers, or to search for a specific public number, a range of public numbers, or a range of public numbers by extension.

To search for a specific public number

1. In the **Directory Number Search** tile, enter a public number in the search box.
2. Click **Go**. Results appear on the [Users List page](#).

To search for a range of public numbers

1. In the **Directory Number Search** tile, enter a public number in the left search box.
2. In the search box at the right, enter a second public number that specifies the end of the search range.
3. Click **Go**. Results appear on the [Users List page](#).



To search for a range of extensions

1. In the **Directory Number Search** tile, enter an extension in the left search box.
2. In the search box at the right, enter a second extension that specifies the end of the search range.
3. Click **Go**. Results appear on the Users List page.

Search from the Premier Home Page

You can search for users from the Premier home page.

To search for users

1. [Log in to Premier](#).
2. In the **Manage Users** tile, select **Public number** or **Extension** from the left drop-down list.
3. In the field at the right, enter a public number or an extension.
4. Click **Go**.

To open the [Users List page](#) in the Customer Portal, click **Advanced search**.

Lists You Can Download

Within the Customer Portal, you'll find downloadable lists of helpful data. The lists are downloaded as CSV (comma-separated values) files, a type of spreadsheet.

To download a list

1. Click the link for the list you want. A File Download window opens.
2. Click **Save**. The file is downloaded to your default directory (or you can specify a different location).

What's New in the Group Administrator Customer Portal

We've made a number of recent additions and improvements to the AT&T IP Flexible Reach Enterprise Administrator Customer Portal, giving you even more power and flexibility in managing your enterprise.

Departments

You can now administer at the department level. Besides belonging to the enterprise and to a group, users can belong to a department. A user can belong to only one department. A department can contain users from all one group (a group department), or it can contain users from various groups (an enterprise department).

Enterprise and Group Administrators can create departments and Department Administrators.

Enterprise Administrators, Group Administrators, and Department Administrators can manage group departments. Only Enterprise Administrators can manage an enterprise department.

Intercept Announcement Feature

We've added the Intercept Announcement feature. When a call comes in to a specific IP Flexible Reach number, the system intercepts the call and plays an announcement instead of connecting it to the number. For example, "Our office is closed; please press zero for assistance" or "This number is no longer in service."

Enterprise Administrators and Group Administrators can set intercept announcements at the group level and for individual users. Department Administrators can set intercept announcements for individual users in their department.

New Reports

AT&T IP Flexible Reach now features three new reports:

- Feature Configuration Report – This report indicates the status of each inbound and outbound call feature for phone numbers or extensions in your enterprise.
- Trunk Call Routing Summary Report – This report provides details about one or more trunk call routing schemes.
- Trunk Call Routing Assigned Users Report – This report provides information about the trunk call routing schemes in your enterprise and each scheme's corresponding users.

Premier Login Changes

To recover a password, Premier now requires answers to two Secret Questions. If you entered only one Secret Question/Secret Answer when you originally registered with Premier, set up a second Secret Question/Secret Answer in your Premier profile now.



When you click **Log In** on the Premier Login page, the Update My Login Profile page appears. In the **Setup Second Security Question** window that opens, enter an additional Secret Question and Secret Answer, and then click **Continue**. (To proceed to the Premier home page without updating your profile, click **Not Now**. You can log in three times and select **Not Now** before you must set up your second Secret Question/Secret Answer.)

What is AT&T IP Flexible Reach?

AT&T IP Flexible Reach is a trunking service that delivers an integrated access solution for the following environments:

- Time division multiplexing private branch exchanges (PBXs)
- Internet protocol private branch exchanges (IP PBXs)
- Key analog systems

IP Flexible Reach can operate with the Session Initiation Protocol (SIP), supporting inbound and outbound calling across the AT&T IP network. It takes advantage of the AT&T Global Multiprotocol Label Switching (MPLS) network to provide local, nationwide, and international long distance reach for U.S. sites.

To make management of functions and features easy, AT&T provides Enhanced IP Flexible Reach customers with a portal (the AT&T IP Flexible Reach Customer Portal).

Can I skip the Premier home page and go straight to the Customer Portal?

No. To reach the Customer Portal, you must first log in to Premier. Then use the links and features on the Premier home page to help manage your group.

User Management Questions

Why is the User Management page blank when there are users in the Customer Portal?

If there are more than 1,000 users in the enterprise you have to use the search function to narrow the list of users.

Can I give individual users access to Customer Portal tools?

Yes. As a Group Administrator, you can grant and revoke permissions that allow users to manage some of their own features.

The user's ID appears in generic form in the Customer Portal. Can I change that?

Yes. The generic **First Last name** (for example, **User, 7775201332**) that appears on the **Profile** tab of the Customer Portal is generated by the system when the phone number is provisioned. As a Group Administrator, you can change the generic name by editing the user's profile.

A user may contact you requesting such a change. See [Edit User Profiles](#) for instructions on changing a user's name in the Customer Portal. Note that changing a user's name in the Customer Portal does not change how the user's name appears in Premier.

Users can edit their own names in Premier, but not on the **Profile** tab in the Customer Portal. Only administrators can edit the name on the **Profile** tab.

When users edit their names in Premier, the edited name appears in the Customer Portal's **Welcome** banner but not on the **Profile** tab.

Do I have to manage call features one user at a time?

You can manage features using the Bulk Management tool within your particular group, up to 1,000 users at a time.

What is a FAC (feature access code) and how does it work?

A feature access code (FAC code) is the key sequence you press on a phone to perform a function. For example, if "Anonymous Call Rejection Activation" is set to ***77**, you press ***77** on the phone to activate that feature. Feature access codes are also called star (*) codes and pound (#) codes.

As a Group Administrator, you can use the Customer Portal to manage feature access codes for your group. When you change a feature access code for your group, you change the code for every user in that group.

What is Trunk Burst and how does it work?

Bursting and sharing is functionality that allows for calls that go beyond the maximum number allowed on the trunk to borrow call capacity from another group trunk group within your enterprise.

The maximum group trunk group burst can't exceed 20% of a group trunk group's maximum concurrent call limit. Bursting and sharing is initially set to false and is managed by AT&T. If your Enterprise wants to utilize or make changes to this functionality, contact your AT&T account representative.

The Trunk Burst setting on a group trunk group indicates whether your Enterprise is using this functionality or not. The setting is either true or false.

You can create schedules at the Group level and the User level.

Account codes are used to track the calls placed by the user in association with a particular account. What is a CSV file?

Glossary

% Allocation

A [trunk call routing](#) algorithm that enables you to assign a percentage of the incoming calls to each [group trunk group](#) in the trunk call routing scheme. The sum of all allocations must be 100.

account code

A feature that enables you to track outbound calls. As a Group Administrator, you create [account codes](#) that users can apply to certain calls for tracking purposes.

There are two kinds of account codes: [mandatory account code status](#) and [optional account code status](#).

algorithms

Settings that govern how calls flow through a [trunk call routing scheme](#). The AT&T IP Flexible Reach Customer Portal provides four algorithms: [Most Idle](#), [% Allocation](#), [Round Robin](#), and [Linear](#).

anonymous call rejection

The Anonymous Call Rejection feature enables a user to reject calls that don't have caller ID attached.

assign

To add an element (such as a user) to a group, group trunk group, or trunk call routing scheme.

authorization code

A feature that enables you to manage outbound calls. As a Group Administrator, you can create and provision [authorization codes](#) for different types of outgoing calls. If required, users must enter a specified authorization code when making a call (except for emergency or repair calls) outside their group.

bulk management tool

The bulk management tool enables administrators to assign options or features to multiple users within a group, up to 1,000 users at a time.

call acceptance

The Call Acceptance feature enables a user to define criteria that permit certain incoming calls to ring through. All other calls are blocked, and the caller is informed that the user doesn't want to receive the call.

call forwarding – always

The Call Forwarding – Always feature enables a user to redirect all incoming calls to another phone number.



call forwarding – busy

The Call Forwarding – Busy feature enables a user to redirect calls to another number when an incoming call encounters a busy condition.

call forwarding – no answer

The Call Forwarding – No Answer feature enables a user to redirect calls to another number when an incoming call isn't answered within a specified number of rings.

call forwarding – not reachable

The Call Forwarding – Not Reachable feature enables a user to set an alternate phone number (for example, a wireless number) where calls are redirected when the user's IP Flexible Reach telephone number is unreachable.

call forwarding – selective

The Call Forwarding – Selective feature enables a user to define criteria that redirect certain incoming calls to another number.

call rejection

The Call Rejection feature enables a user to define criteria that reject certain incoming calls.

calling line ID

The Calling Line ID setting allows you to customize the number that will appear on a call recipient's caller ID when the user makes an outbound call. Use this feature to mask a user's public number with your company's customer support number when the user calls your customers.

CSV file

A comma-separated values file, which stores table data in plain-text form, allowing for easy handling in any text-editing program. You open CSV files in spreadsheets. Files that you download from the Customer Portal, such as a [Group ID and Name List](#) or a [Group Users List](#), are downloaded as CSV files.

department

A department is a subdivision of a group or enterprise to which users can be assigned. An **Enterprise Department** can include any user in the enterprise. A **Group Department** can include users from a single group.

Department Administrator

The administrator class that ranks third in the AT&T IP Flexible Reach administrator hierarchy. Department Administrators manage users within a group department. Enterprise Administrators manage departments that span more than one group.



dial plan type

A setting in a group profile that represents the AT&T service plan purchased. Possible settings are **Public Only**, **Private Only**, or **Public & Private**.

dial restriction

A limit that you can impose to manage a group's outgoing calls. You can also set custom [dial restrictions](#), for individuals.

enterprise

The complete AT&T IP Flexible Reach setup, including all users, groups, departments, group trunk groups, and trunk call routing schemes, along with the phone lines.

Enterprise Administrator

The administrator class at the top of the AT&T IP Flexible Reach administrator hierarchy. Enterprise Administrators manage group trunk groups, trunk call routing schemes, Group Administrators, Department Administrators, and users.

enterprise contact

A [person you can contact](#) for advice and assistance with the Customer Portal, your enterprise, and your group.

enterprise ID

A 10-digit number that identifies an AT&T IP Flexible Reach enterprise.

FAC (feature access code)

The key sequence a user presses on a phone to perform a function. For example, if the Anonymous Call Rejection Activation feature is set to *77, users press ***77** to activate that feature on their phones. [FACs](#) are also called star (*) or pound (#) codes.

forward always action for a group trunk group

When Forward Always Action is set, any calls that normally use the group trunk group are forwarded to a location set by the administrator.

group

A set of users who share certain things in common—most notably, the [group trunk group](#) used to access their site or location. A [group](#) has these attributes:

- A unique location dialing code
- A single extension length
- A set of assigned phone numbers
- A set of users assigned to those phone numbers
- A unique numeric identifier (group ID) and name (group name)



Group Administrator

The administrator class that ranks second in the AT&T IP Flexible Reach administrator hierarchy. Group Administrators manage departments, group trunk groups and users.

group ID

The number that represents a particular group. You can look up groups by name or ID.

group name

The name of a particular group. You can look up groups by name or ID.

group trunk group

The path a call takes between AT&T IP Flexible Reach and the organization's private branch exchange (PBX), and ultimately the user. The [group trunk group](#) has a set maximum number of calls, incoming and outgoing, that it can handle simultaneously.

GTG

An abbreviation for group trunk group.

inbound call features

Call features that enable users to manage calls they receive in various ways. For example, the Anonymous Call Rejection feature enables a user to reject calls that don't have caller ID. The Call Forwarding features enable a user to automatically forward calls to a different number.

As part of managing user access to the AT&T IP Flexible Reach Customer Portal, you assign users rights to use individual [inbound call features](#).

initial event

An event in a [schedule](#) of any level that acts as the template for any recurrences of that event. An initial event can occur only once, or you can set it to recur on a daily, weekly, monthly, or yearly interval.

Intercept Announcement

Intercept Announcement plays an announcement when the user receives a call. When this setting is turned on, the call is intercepted and the specified messages are played to the caller. These announcements can also provide call routing options.

linear

A trunk call routing algorithm. With the Linear algorithm, you set the order in which group trunk groups receive traffic. If the first group trunk group isn't available or has reached its capacity for concurrent calls, AT&T IP Flexible Reach then routes traffic to the next group trunk group in the trunk call routing scheme, and so on.



load distribution

How the load of incoming calls is distributed throughout available [group trunk groups](#). See [Trunk Call Routing](#).

location code

A code number for a private branch exchange (PBX). The location code plus the user extension form the private phone number.

Mandatory Account Code status

Users with the [Mandatory Account Code](#) status are prompted to enter a required account code when making a call (except for emergency and repair calls) outside the group. See [Optional Account Code status](#).

max DID policing

The Max DID Policing feature enables the organization to limit the number of concurrent calls that come in to a specific phone number.

maximum concurrent calls

A [group trunk group](#) setting that sets the number of simultaneous calls that can be handled at one time. The incoming and outgoing concurrent call values must be less than or equal to the value set for Maximum Concurrent Calls.

most idle

A [trunk call routing](#) algorithm that enables you to route calls to the least-used [group trunk group](#) in the multiple trunk group arrangement.

multiprotocol label switching (MPLS)

A technology that speeds up and simplifies data transmission in high-performance telecommunications networks. Multiprotocol Label Switching (MPLS) works by substituting short path labels for long network addresses as it moves data along a string of network nodes. MPLS can be used with any networking protocol, and it supports T1/E1, ATM, Frame Relay, and DSL, among other technologies.

Optional Account Code status

Users with the [Optional Account Code](#) status can enter an account code when making a call outside the group, but it isn't required. See [Mandatory Account Code status](#).

outbound call features

Features that affect the way an outgoing call is placed. Account codes, authorization codes, and dial restrictions are all [outbound call features](#).



PBX

Private branch exchange (PBX), a subscriber-owned telecommunications exchange (private telephone switchboard) that usually includes access to the public switched telephone network. It provides on-premises dialing service and may provide connections to local and trunked communications networks.

Premier

The one-stop, customizable online site where business customers, large and small, can learn about, purchase, monitor, and manage wireless, Voice over IP, and related products and services. To administer the AT&T IP Flexible Reach Customer Portal, you must first [log in](#) to [Premier](#).

private number

A phone number to be used within an enterprise. It routes the call from the private branch exchange (PBX) to the individual user. Commonly called an extension.

public number

A phone number dialed from outside the enterprise that routes the call to a private branch exchange (PBX). Commonly called a phone number.

recurring event

Any event in a schedule that's repeated. You can set recurring events to recur on a daily, weekly, monthly, or yearly interval.

redirecting party

The phone number that directs an incoming call to a different number.

re-routes

The number of times a call can be re-routed within a [trunk call routing scheme](#) before it's terminated or forwarded. The maximum number of possible re-routes is 10.

round robin

A [trunk call routing](#) algorithm. Like the Linear algorithm, the Round Robin algorithm selects resources in sequence. But the Round Robin algorithm has an added feature: Instead of waiting for one group trunk group to reach capacity before it directs calls to the next, the Round Robin algorithm balances the call volume evenly across all group trunk groups.

route exhaust

In a [trunk call routing scheme](#), the setting that specifies how calls are handled when they exceed a set maximum number of re-routes.

Schedule

Schedules consist of one or more events. For example, a single holiday schedule might contain events for holidays such as Thanksgiving and the 4th of July.



The events that are added to a schedule determine when specific features are applied to a user's incoming calls. The features that can be controlled through schedules are **Call Acceptance**, **Call Rejection**, **Call Forwarding – Selective**, **Sequential Ring**, and **Simultaneous Ring**.

scheme

A complete [trunk call routing](#) design.

selective criteria

Settings within an [inbound call feature](#) that you can use to customize the way that the feature works. As an Enterprise Administrator, you can set selective criteria for a user, or you can allow users to set selective criteria for themselves.

Sequential Ring

The Sequential Ring feature enables a user to define a “find-me” list of phone numbers that are alerted sequentially when incoming calls match a user's specified criteria. (If the user can't be reached at the first number, the service tries the second number. If the user can't be reached at the second number, the service tries the third number, and so on.)

Session Initiation Protocol (SIP)

A signaling used to control sessions with one or more participants. The Session Initial Protocol (SIP) is used for Internet phone calls and multimedia transmission.

Simultaneous Ring

The Simultaneous Ring feature enables a user to have up to 10 phone numbers ring simultaneously when calls are received on the user's IP Flexible Reach phone number. The first phone to be answered is connected.

TCR

An abbreviation for trunk call routing scheme.

tile

A section of a webpage that contains links or information about a particular function or action.

trunk call routing scheme

In an AT&T IP Flexible Reach enterprise, the mechanism used to route calls across distinct routes. Each distinct route is called a [group trunk group](#). When you bundle these routes for traffic management, you create a [trunk call routing scheme](#).

unassign

To remove an element (such as a user or a group trunk group) from a group, group trunk group, or trunk call routing scheme.



unreachable destination

When an incoming call can't be routed successfully because this group trunk group is at capacity (i.e., the maximum concurrent call limit has been exceeded) or is unreachable for other reasons, the Unreachable Destination action is applied. Options are:

- **None:** No Unreachable Destination action is applied when incoming calls can't be routed.
- **Phone Number:** The phone number to which incoming calls should be forwarded when the destination is unreachable. The phone number can be public, private, or international.
- **Group Trunk Group:** The group trunk group to which incoming calls should be routed when the destination is unreachable.

unreachable destination timer

When an incoming call can't be routed successfully over this group trunk group within the specified number of seconds, the Unreachable Destination action is invoked.

user portal access

The User Portal Access setting allows you to request portal access for a user in your group. When you request portal access for a user, an email is sent to the email address of that user so they can set up their portal account. You can also revoke access for users in your group.

Overview

Enterprises with AT&T Enhanced IP Flexible Reach are composed of groups, and each group has one or more users. Each group has a single group trunk group, which is the path a call takes between AT&T IP Flexible Reach and your organization's PBX (private branch exchange), which routes the call to the appropriate number and user. The group trunk group has a maximum number of calls, incoming and outgoing, that it can handle simultaneously. Trunk call routing sets up schemes that determine how calls are routed through group trunk groups.

Enterprises and groups can also be subdivided into sets of users called departments. An Enterprise Department can include any user in the enterprise. A Group Department can include users from a single group.

A user's identity and initial access to the AT&T IP Flexible Reach Customer Portal is created by your organization's system administrator. The user's identity consists of the user's name, public phone number, private phone number, and email address.

As a Group Administrator, you can manage users only within their specific group. Enterprise Administrators can manage all users within the entire enterprise. Department Administrators can manage users only within their specific department.

Edit User Profiles

Through Premier, your organization's system administrator sets up a user's identity and access to the AT&T IP Flexible Reach Customer Portal. The user's identity consists of the user's name, public phone number, private phone number, and email address.

After the user identity is created, you can, as a Group Administrator, use the Customer Portal to edit names, calling line IDs, and time zones for users within your group.

Calling line ID is the phone number that's displayed on the called party's phone when a user places a call. The default is the user's public number. You can customize calling line ID by specifying a different number (up to 40 digits). For example, you may want the calling line ID to be for a sales office or reception desk.

Note: For emergency calls, the calling line ID will always be the user's public number.

To edit a user's profile information




1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar. The Users List page appears.
2. Locate the user whose profile you want to edit. (You can search, scroll or page through the list, or click a number to jump to a specific page.)
3. Click the user's first or last name. The User Details page appears.
4. Click the **Profile** tab. The Profile view appears.
5. Click **Edit**. The Edit view of the user's profile appears. You can edit the user's last name, first name, calling line ID, and time zone.
6. Enter changes, and then click **Save**.



View Call Logs

As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can view logged calls for individual users in your group. This information can help managers track staff performance and plan shifts in resources. Users can also view details for their own call logs.

To view user call logs

5. If you selected **Group**, click **Save**. If you selected **Custom User**, edit dial restrictions for this user, and then save your changes.
 6. To edit all custom user restrictions for this user at once, from the **Select All Custom User Restrictions** drop-down list, select restrictions. (To edit dial restrictions for this user one at a time, skip to step 7).
 - To allow the user to use all the restricted outbound call features listed, select **Allow**.
 - To block the user from using all the restricted outbound call features listed, select **Block**.
 - To use the group-level authorization code requirements for all restricted outbound call features listed, select **Standard Authorization**.
 7. To edit dial restrictions for this user one at a time, from the **Custom User Restrictions** drop-down list, select a dial restriction.
 - To allow the user to use a restricted outbound call feature, select **Allow**.

Create a Schedule for a User

If you create a schedule for a group that a user is part of, that user is automatically added to that schedule. You can also create a schedule for an individual user.

Users can create, edit, and delete their own individual schedules.

To create a schedule for an individual user

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar. The [Users List page](#) appears.
2. Click the name of the user you want to work with. The [User Details page](#) appears.
3. Click the **Schedules** tab. The Schedules page appears.
4. Click **Create Schedule**. The Create Schedule page appears.
5. Enter a name for the schedule.
6. For the schedule type, select **Holiday** or **Time**. (The **Time** type is used for all schedules other than **Holiday** schedules.)
7. Under Schedule Level, select **User**.
8. Click **Create**. The Schedule Details page for the new schedule appears.

Note: After you've created a schedule, you must add one or more events to it.





Add an Event to a User's New Schedule

A schedule must contain one or more events. The Initial Event is the template for Recurring Events.

To add an event to a user's new schedule

When you first create a new schedule, the Schedule Details page appears.

1. To the right of the schedule name, under **Actions**, click the Edit icon . The Schedule Details page opens in Edit mode.
2. Click  **Add Event**. The Add Event page appears.
3. Under **Initial Event**, enter the event name.
4. Enter a start date and an end date for the event.
5. Enter a start time and an end time for the event.
6. If you want the event to occur more than once, under **Event Recurrence**, select whether you want the event to recur daily, weekly, monthly, or yearly.

Note: If this is a one-time event, don't set **Event Recurrence**.

7. If this event recurs, select the recurrence details, and then select a recurrence end date (if appropriate).



Note: If the event will continue on a daily, weekly, monthly, or yearly interval, don't set **Recurrence End**.

8. Click **Add**. The Event Details page appears.
9. To add more events to this schedule, under **Add Event**, follow steps 3–8.

Manage a User's Schedules and Events




You can edit or delete a user's schedules. You can also add, edit, and delete events within a user's schedule.

To manage a user's schedules

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar. The [Users List page](#) appears.
2. Click the name of the user you want to work with. The [User Details page](#) appears.
3. Click the **Schedules** tab. The [Schedule List page](#) appears.
4. Locate the schedule you want to edit.
 - To edit a schedule, under **Actions**, click the **Edit** icon . (For more information, see [Edit a Schedule](#).)
 - To delete a schedule, under **Actions**, click the **Delete** icon . (For more information, see [Delete a Schedule](#).)



To manage a user's scheduled events

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar. The [Users List page](#) appears.
2. Click the name of the user you want to work with. The [User Details page](#) appears.
3. Click the **Schedules** tab. The [Schedule List page](#) appears.
4. Locate the schedule that contains events you want to edit, and then click the schedule name. The [Schedule Details page](#) appears.
5. Scroll down to the **Events** tile.
 - To create a new event, click  **Add Event**.
 - To edit an event, under **Actions**, click the Edit icon .
 - To delete an event, under **Actions**, click the Delete icon .



Manage Premier User Profiles

As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can search or browse for users who can access Premier directly from the Premier homepage. You can also grant a user in your group access to the Customer Portal, initiate a user's Premier password reset, or revoke a user's Premier access.


Note: You can only manage users who are in your group.

To grant a user access to the Customer Portal

1. Log in to [Premier](#). Or, from the Customer Portal, click **Premier Home** at the upper-right of the page. The Premier homepage appears.
2. In the **Administrator and User Profiles** tile, under **Manage Administrators and Users**, click **Manage Premier user profiles**. The Manage Premier User Profiles page appears.
3. To give a user access to Premier, under **Create Premier User Profile**, click **Give a user access to Premier**. The [Users List page](#) appears.
4. Locate the user who needs access to the Customer Portal. (You can search, scroll or page through the list, or click a number to jump to a specific page.)
5. Click the user's name. The [User Details page](#) appears.
6. Click the **Profile** tab. The user's profile shows a list of settings, including **User Portal Access**.
7. At the right of **User Portal Access**, click **Submit Request**. A Submit Request window opens.
8. Enter the user's email address, and then click **Save**. The system sends the user email with instructions for how to register for Customer Portal access.

To search or browse for a Premier user profile

You can search for user profiles under **Search for a Premier User Profile** on the Manage Premier User Profiles page.

1. Log in to [Premier](#). Or, from the Customer Portal, click **Premier Home** at the upper-right of the page. The Premier homepage appears.

4. Click **Reset Password**. The User password reset page appears.
5. Click the **Reset Password** button. An email is then sent to the email address on file for the user. The email has instructions for how the user can reset his or her password.

To revoke a user's Premier access

1. Log in to [Premier](#). Or, from the Customer Portal, click **Premier Home** at the upper-right of the page. The Premier homepage appears.
2. In the **Administrator and User Profiles** tile, under **Manage Administrators and Users**, click **Manage Premier user profiles**. The Manage Premier User Profiles page appears.
3. Locate the user whose profile you want to edit. (You can search, scroll or page through the list, or click a number to jump to a specific page.)
4. Click **Delete**. The Profile tab of [User Details page](#) appears.
5. At the right of **User Portal Access**, click **Remove Access**. A Remove Access confirmation window opens.
6. To remove the user's access, click **OK**. To retain the user's access, click **Cancel**.
7. If you clicked **OK**, the Profile view refreshes, and the user can no longer access the Customer Portal.

Overview

As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can manage the features available to your group's users all together, in bulk, for up to 1,000 users at a time. (You can manage the calling line ID feature for up to 60,000 users at a time. Be sure to perform such a large transaction during off-peak hours.)

If you have only a few users to manage, edit the users' features individually. The Bulk Management tool works best when you're managing more than a dozen users at one time.

To manage features for multiple users in your group at one time, download the feature template from the Bulk Management tool. Complete the template, and then upload it into the system.

You can also manage other aspects of your group in bulk, such as account and authorization codes, and user access.

Edit a Feature Using the Bulk Management Tool

Follow this process to edit most features for more than one user at a time.

To edit a feature in bulk

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, select the feature you want to manage.
3. Next, download the feature template. To the right of **Download Template**, click the link.
4. When the File Download window opens, save the template by clicking **Save**. The template is downloaded as a comma-separated values (CSV) file, which is a type of spreadsheet. The file will be downloaded to your default directory, or you can choose a different location.
5. Edit the template.

Template Editing Tips:

- Before submitting the spreadsheet, delete the template example row.
- The public number or extension is required. The extension can also be considered the private number.
- The Group ID must be the same for every entry in the file.
- Like the template you downloaded, the file you upload must be a CSV file.
- Be careful with cell formatting. For any cells that contain or may contain data with leading zeroes (for example, group ID and extension), enclose the data in double quotation marks ("0192"), or change the cell format to Text before you enter the data.
- [Download the group user list](#) so that you can copy user names and paste them into the template.
- You can add a maximum of 1,000 users in the same group to a single file (60,000 for calling line ID).



- The uploaded file must have at least one valid row of user data (in addition to the header row).
 - Any fields you leave blank maintain the current values for those fields; the values won't be updated.
6. When you're done, save the file as a CSV file. (Don't change the file type.)
 7. Upload the edited template by clicking **Upload Template**. Your default folder opens. Browse for and select the file you just edited. The file appears in the **Upload** field.
 8. Process the changes by clicking **Run**. The results appear in the **Result Log**.

Download the Group's Users List

The easiest way to manage your group's users in bulk is to download that group's Group Users list, and then copy and paste the contents of the downloaded list into a bulk management template.

Note: Remember, you can manage features in bulk for up to 1,000 users within your group at a time. If your group has more than 1,000 users, you must divide the group and submit separate CSV files. (Exception: up to 60,000 users for calling line ID.)

To download the Group Users list

1. From any page in the Customer Portal, click **RESOURCES**, and then click **Group** immediately below. The Group Page appears.
2. Click the **Group Users** tab. The Group Users view appears.
3. Below the **Search** button, click **Download Group Users List**. A File Download window opens.
4. Click **Save**. The file containing the group ID numbers, names, and phone number information of all users in the group is downloaded to your default download directory, or you can specify a different location.

Manage Account Codes


You can edit account code values (numbers) and the account code users list in bulk.

To edit account code values




1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, on the Bulk Management page, select **Account Code Values**.
3. To the right of **Download Template**, click **Account_Code_Values.csv**. The File Download window opens.
4. Click **Save**. The template is downloaded as a comma-separated values (CSV) file. The file will be downloaded to your default directory, or you can specify a different location.
5. Open the downloaded file and enter the group ID number, the account code numbers, and the account code descriptions.

Note: Account codes must each be unique within the group, and all account codes within a group must be the same length. You can change the account code length for a group, but note that changing the length nullifies all account codes created earlier.

6. Save the file as a CSV file.
7. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
8. Click **Run**. The Account Code Values template is processed. Results appear under **Result Log**. To view the file, click the Report icon .

To edit the account code users list


1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list on the Bulk Management page, select **Account Code Users List**.
3. At the right of **Download Template**, click **Account_Code_Users_List.csv**, and then save the file.
4. Open the saved file, enter the group ID number and edit the account code users list. You can copy and paste users' public numbers and extensions. (See [Download the Group's Users List](#), above.)
5. Set whether account codes are mandatory or optional for this group of users. Under **Mandatory** and **Optional**, enter **Y** for yes and **N** for no. Note that account codes can't be both mandatory and optional.
6. Save the file as a CSV file.
7. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
8. Click **Run**. The Account Code Users template is processed. Results appear under **Result Log**. To view the file, click the Report icon .



Manage Authorization Codes

You can edit authorization code values (numbers) in bulk.

To edit authorization code values

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, select **Authorization Code Values**.
3. To the right of **Download Template**, click **Authorization_Code_Values.csv**, and then save the file.
4. Open the file and enter the group ID number.
5. Edit the authorization code numbers. Authorization codes must be between 2 and 14 digits long, and the codes must each be unique within the group.
6. Edit the authorization code descriptions, and then save the file as a CSV file.
7. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
8. Click **Run**. The Authorization Code Values template is processed. Results appear under **Result Log**. To view the file, click the Report icon .

To view the authorization code sync results

 6. Select whether the inbound call feature is available and active for users. Under **Available** and **Active**, enter **Y** for yes or **N** for no.
 7. Fill out the rest of the information on the spreadsheet. Not all features are filled out in the same way.
 8. Save the file as a CSV file.
 9. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
 10. Click **Run**. The template is processed. Results appear under **Result Log**. To view the file, click the Report icon .


Manage Dial Restrictions

You can edit dial restrictions for up to 1,000 users at a time within your group.

To edit bulk dial restrictions

Manage User Names

The system generates the generic **First Last name** (for example, **User, 7775201332**) that appears on the user's **Profile** tab when the phone number is provisioned. As a Group Administrator, you can change the generic name by editing the user's profile. Or, you can use the **Manage User Names** template to manage up to 1,000 user names in your group at a time.



To manage user names in bulk

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, select **Manage User Names**.
3. At the right of **Download Template**, click **Manage_User_Names.csv**, and then save the file.
4. Open the saved file and enter the group ID number.
5. Edit user names. You can copy and paste users' public numbers, extensions, and names from the group users list. (See [Download the Group Users List](#), above.)
6. Save the file.
7. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
8. Click **Run**. The Manage User Names template is processed. Results appear under **Result Log**. To view the file, click the Report icon .

Manage Calling Line ID

You can manage calling line IDs for up to 60,000 users at a time.

To manage calling line ID in bulk

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management** immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, select **Calling Line ID**.
3. At the right of **Download Template**, click **Calling_Line_ID.csv**, and then save the file.
4. Open the saved file and enter the group ID number.
5. Edit user numbers. You can copy and paste users' public numbers and extensions from the group users list. (See [Download the Group Users List](#), above.)
6. For each number, specify whether to use the calling line ID or the user's public number or extension. In the **Use Configurable CLID** column, enter **Y** (yes) to use the calling line ID; to use the user's public number or extension, enter **N** (no).
7. If the **Use Configurable CLID** column is set to **Y**, enter a number in the **Calling Line ID** column. If it's set to **N**, leave **Calling Line ID** blank.

Note: You can enter only one calling line ID, up to 15 digits, per user. Do not enter extensions. Public numbers must be 10 digits without a leading 1. Add the prefix 011 for international numbers and enclose the whole number in quotation marks (for example, "011330555111").

8. Save the file.
9. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.




10. Click **Run**. The Calling Line ID template is processed. Results appear under **Result Log**. To view the file, click the Report icon.

Manage Max DID Policing


You can edit Max DID Policing settings for up to 1,000 users at a time within a group.

The Max DID Policing feature enables the organization to limit the number of concurrent calls that come in to a specific phone number.

To manage Max DID Policing settings

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar, and then click **Bulk Management**, immediately below. The Bulk Management page appears.
2. From the **Select Option** drop-down list, select **Max DID Policing**.
3. At the right of **Download Template**, click **Max_DID_Policing.csv**, and then save the file.
4. Open the saved file and enter the group ID number.
5. Edit public numbers and extensions (used to identify users). You can copy and paste users' public numbers and extensions from the group users list. (See [Download the Group Users List](#), above.)
6. Select whether customer settings are in place for each user. Under **Active**, enter **Y** for yes or **N** for no.
7. Under **Maximum Concurrent Calls**, enter the maximum number of concurrent calls allowed for each user. The number entered should be between 1 and 500.
8. Save the file.
9. Click **Upload Template**. Browse for and select the file you just edited. The file name appears in the **Upload Template** field.
10. Click **Run**. The Max DID Policing template is processed. Results appear under **Result Log**. To view the file, click the Report icon .

Manage Errors

If the uploaded template contains any errors, you'll see **Processed with Errors** in the **Status** column of the **Result Log** area. For details, click the Report icon .

- If the template was used for editing user information, the results file shows one row with status for each user.
- All rows in the spreadsheet are submitted independently (for example, if there's an error in row 1, row 2 is still submitted).
- An error could be as simple as a required cell left blank. Resolve any errors and resubmit the spreadsheet. Or, you can copy rows with errors into another spreadsheet, delete the row from the original spreadsheet, and then rerun the new spreadsheet. You don't need to rerun successful user rows.
- If there's some overarching problem that prevents the spreadsheet from being processed, no result file appears, and you'll see an error message that takes you back to the Bulk



Management page and the **Run** button. If this occurs, find and correct the error, and then rerun the entire spreadsheet.

Overview

Inbound call features enable users to manage calls they receive in various ways. For example, using Anonymous Call Rejection, a user can reject calls that don't have caller ID. Call Forwarding features enable a user to automatically forward calls to a different number.

For some features you specify selective criteria that help define when and how the features are activated.

You specify selective criteria rules that evaluate an incoming call to determine whether and how to use a feature. Using selective criteria rules in these features is optional. If you don't define any selective criteria rules, the feature will apply for every call.

As part of managing group user access to the AT&T IP Flexible Reach Customer Portal, you grant users rights to use individual inbound call features, and customize many features.

This section outlines the inbound call features and explains what they do.

Anonymous Call Rejection

The Anonymous Call Rejection feature enables a user to reject calls that don't have caller ID attached. If the caller isn't identified, the user can reject the call. When this feature is activated, Anonymous Call Rejection instantly rejects all anonymous calls, preventing the caller from even leaving a message. This feature also appears as a sub-option of the Call Acceptance, Call Rejection, Sequential Ring, and Simultaneous Ring features.

Anonymous Call Rejection doesn't have selective criteria.

Call Acceptance

The Call Acceptance feature enables a user to define criteria that permit certain incoming calls to ring through. All other calls are blocked, and the caller is informed that the user doesn't want to receive the call.

Call acceptance has selective criteria.

Call Forwarding – Always

The Call Forwarding – Always feature enables a user to redirect all incoming calls to another phone number.



Call Forwarding – Always doesn't have selective criteria.

Call Forwarding – Busy

The Call Forwarding – Busy feature enables a user to redirect calls to another number when an incoming call encounters a busy condition. The line is considered to be busy when there are too many active calls coming through at once, or when Call Acceptance or Call Rejection is in use.

Call Forwarding – Busy doesn't have selective criteria.

Call Forwarding – No Answer

The Call Forwarding – No Answer feature enables a user to redirect calls to another number when an incoming call isn't answered within a specified number of rings. You (the administrator) or the user must specify the forwarding number and the number of rings before forwarding.

Call Forwarding – No Answer doesn't have selective criteria.

Call Forwarding – Not Reachable

The Call Forwarding – Not Reachable feature enables a user to set an alternate phone number (for example, a wireless number) where calls are redirected when the user's IP Flexible Reach telephone number is unreachable.

Call Forwarding – Not Reachable doesn't have selective criteria.

Call Forwarding – Selective

The Call Forwarding – Selective feature enables a user to define criteria that redirect certain incoming calls to another number. If an incoming call meets specified criteria, the call is redirected to the specified number.

Call Forwarding – Selective has selective criteria.

Call Rejection

The Call Rejection feature enables a user to define criteria that reject certain incoming calls. If an incoming call meets specified criteria, the call is blocked and the caller is informed that the user doesn't want to receive the call.

Intercept Announcement

With the Intercept Announcement feature, an incoming caller hears a recorded announcement instead of being connected to the called number. The announcement can be standard or custom. Announcements can be active at the enterprise or group level, or for individual users' numbers.

If enabled, Intercept Announcement overrides all other active features and selective criteria.

Max DID Policing

The Max DID Policing feature enables the organization to limit the number of concurrent calls that come in to a specific phone number.

Max DID Policing doesn't have selective criteria.

Sequential Ring

The Sequential Ring feature enables users to define a "find-me" list of phone numbers that are alerted sequentially when incoming calls match a user's specified criteria. (If the user can't be reached at the first number, the service rings the second number. If the user can't be reached at the second number, the service rings the third number, and so on.) While the service searches for the user, the caller hears a greeting, followed by periodic announcements.

Sequential Ring has selective criteria.

Note: A user can't use Sequential Ring and Simultaneous Ring at the same time. If both features are set to **Active**, Sequential Ring takes precedence.

Simultaneous Ring

The Simultaneous Ring feature enables users to have up to 10 phone numbers ring simultaneously when calls are received on the user's IP Flexible Reach phone number. The first phone to be answered is connected.

Simultaneous Ring has selective criteria.

Note: A user can't use Simultaneous Ring and Sequential Ring at the same time. If both features are set to **Active**, Sequential Ring takes precedence.

Grant a User Access to Inbound Call Features

You can grant a user access to any or all inbound call features. (Note that Max DID Policing is available only to Enterprise and Group Administrators.)

Go to the [User Details page](#) and click the **Features** tab.

- To enable access, in the feature's **Available for User** column, select **Yes**.



- To block access, in the feature's **Available for User** column, select **No**.

To grant a user access to individual features

This overview shows you how to assign access to inbound call features. For instructions on how to assign a specific feature and set its selective criteria, see the help topic for that particular feature.

1. From any page in the Customer Portal, click **USER MANAGEMENT**. The [Users List page](#) appears.
2. Click a user's name. The [User Details page](#) appears, with the **Inbound Features** tab selected (or click the **Inbound Features** tab).

4. For each feature that you want grant access to this user, under **Available for User**, select **Yes**.

Caution: If you revoke and then restore a user's access to a feature, all settings created through the edit process, including saved criteria, will be lost.

About Selective Criteria

Selective criteria are rules that control the behavior of an inbound call feature. You can customize some features using selective criteria. Selective criteria vary from one call feature to another, but you follow the same procedure to set them.

Note: The following inbound call features have simple settings and no selective criteria:

- Anonymous Call Rejection
- Call Forwarding – Always
- Call Forwarding – Busy
- Call Forwarding – No Answer
- Call Forwarding – Not Reachable
- Max DID Policing



Note: If the Intercept Announcement feature is active, it overrides all selective criteria rules.

To set selective criteria

This procedure gives you an overview of how to set selective criteria for inbound call features. For instructions on setting specific selective criteria, see the help topic for the particular inbound call feature.

1. From any page in the Customer Portal, in the main menu bar, click **USER MANAGEMENT**. The [Users List page](#) appears.
2. Click a user's name. The [User Details page](#) appears.
3. On the **Inbound Features** tab of the User Details page, click the name of a feature. The feature's Settings page appears.



4. To the upper-right of the **For calls matching** section, click  **Add Criteria**. The Add Criteria page appears.
5. Complete the Add Criteria page.
6. When you've finished setting criteria, click **Add**. A success message appears, along with the new criteria.
7. To create an exception to the rule you've just created, click the **Back to <feature name>** link to go back to the feature's Settings page.
8. In the **Regardless of above settings...** section, click  **Add Criteria** and create your exception.

Inbound Call Feature Precedence

One feature's settings might override those of another feature, even if both are set and **Active**.

Intercept Announcement always unconditionally overrides other features, even if those features are active.

Call Forwarding - Always redirects all incoming calls and takes precedence over most other Call Forwarding features.

Exceptions:

- Call Forwarding - Selective takes precedence for incoming calls that match the defined selective criteria.
- Intercept Announcement overrides all other active features.

In most cases, defining selective criteria for a feature like Call Rejection or Call Acceptance gives precedence to that feature for any calls that match the defined criteria.



Manage Inbound User Call Features— Anonymous Call Rejection

The Anonymous Call Rejection feature enables users to reject calls without caller ID. When this feature is activated, all anonymous calls are instantly rejected, preventing the caller from even leaving a message.

Anonymous Call Rejection also appears as a sub-option of the Call Acceptance, Call Rejection, Sequential Ring, and Simultaneous Ring features.


Note: If Anonymous Call Rejection is active, it takes precedence over other feature settings for anonymous calls. (If enabled, the Intercept Announcement feature takes precedence over all other active features. For details, see [Intercept Announcement](#).)

To set Anonymous Call Rejection

1. From any page in the AT&T IP Flexible Reach Customer Portal, click **USER MANAGEMENT** in the main menu bar. The [Users List page](#) appears.
2. From the Users List page, click a user's name. The [User Details page](#) appears.
3. On the **Inbound Features** tab of the User Details page, in the **Available for User** column, make sure that the feature availability is set to **Yes**.

Caution: If you remove then restore a user's access to a feature, all settings created through the edit process will be lost.

4. In the **Action** column, to the right of **Anonymous Call Rejection**, click the Edit icon . The Edit Anonymous Call Rejection page appears.
5. To turn the feature on, select **Yes**. To turn it off, select **No**.
6. Click **Save**. A message confirms the change.



Manage Inbound User Call Features—Call Acceptance

With the Call Acceptance feature, a user can define criteria that enable certain incoming calls to ring through. All other calls are blocked, and the caller is informed that the user doesn't want to receive the call.

Add or Edit Call Acceptance Criteria

In some cases, users must to set up selective criteria before you assign a feature. With Call Acceptance, users must add selective criteria before it can be used. After criteria has been added, the feature can be edited at any time.

Only active criteria are evaluated as part of the call acceptance settings. (Inactive criteria aren't evaluated.) Active criteria are evaluated in the order listed (alphabetical by description), and call rejection is applied based on criteria matches.


Note: If enabled, the Intercept Announcement feature takes precedence over all selective criteria. For details, see [Intercept Announcement](#).


To add Call Acceptance selective criteria

- To choose a custom schedule, select **Custom Schedule**, and then click **Select Schedule**. The Select Schedule window appears.
 - Search or browse for the schedule you want. To select a schedule, under **Action**, click the Action icon

8. Set **Accept Call(s) from**. Select one of these options:

- **Accept calls from Any Phone Number**—The system accepts a call from anyone.
- **Accept Calls from the Following Phone Numbers**—The system accepts calls only from the specified numbers.

To specify a phone number, select one or any combination of these settings:

- **Any Anonymous Number**
- **Any Unavailable Number**
- **Specific Number(s)**

If you selected **Specific Number(s)**, in the **Phone Number** field, enter a phone number.

- To enter the first number, click **Add a Number**.
- To add each subsequent number, click **Add a Number** again.

You can add up to 12 numbers, each up to 20 digits long. No phone number format validation is enforced. You must enter public numbers in the North American Numbering Plan as 10 digits without domestic prefix or country code.

International numbers must start with + or 011.

Extensions aren't allowed, and you can't block numbers from within your enterprise.

Wildcard characters are allowed:

- Use an asterisk (*) to match any sequence of digits and is used only at the end of a number. It can't be used to replace the entire number. For example:
 - 732*
 - 8*
- Use a question mark (?) to match any single digit anywhere within a specific number entry. It can even replace the first digit of the number. For example:
 - ?52*
 - 73232049??

9. When you've finished adding numbers, click **Add**. A message confirms the change.

You can now edit the criteria you've just created, or add more criteria.



To edit selective criteria

You can create exceptions to the rules you've created.

1. At the upper-right of the Regardless of above settings never accept calls matching section, click **Add Criteria**. The Add Call Acceptance Criteria page appears.
2. Repeat steps 5 and 6 from the add selective criteria procedure above.

Note: If you enter the same number in **Accept Calls Matching** and Regardless of above settings never accept calls matching, the Accept Calls Matching setting takes precedence and calls from that number are accepted.

Set Call Acceptance

After you've added selective criteria, set the Call Acceptance feature for the user.

To set Call Acceptance

1. On the **Inbound Features** tab of the [User Details page](#), under **Action**, click the Edit icon . The Call Acceptance page appears.
2. In the **Accept** calls matching section, under Active, check the checkbox for the setting you want.
3. **Note:** Checkboxes are available only when the page is in Edit mode.
4. In the **Regardless of above settings never accept calls matching** section, check the checkbox for the setting you want. (Optional)
5. To edit a setting, under **Actions**, click the Edit icon .
6. Click **Save**. A message confirms the change.



Manage Inbound User Call Features—Call Forwarding - Always

The Call Forwarding – Always feature enables users to redirect all incoming calls to another phone number.

Call Forwarding - Always redirects all incoming calls, and it takes precedence over most other Call Forwarding features. The only exception is Call Forwarding - Selective, which takes precedence for incoming calls that match that feature's selective criteria.

Note: If enabled, the Intercept Announcement feature takes precedence over all other active features. For details, see [Intercept Announcement](#).

Forwarded callers are treated according to the forward-to phone number's settings. For example, if the forwarded call isn't answered, callers may be prompted to leave voicemail for the forwarded phone number, not for the first phone number.

Manage Inbound User Call Features—Call Forwarding - Busy

The Call Forwarding – Busy feature enables a user to redirect an incoming call to another number when it encounters a busy condition. The line is considered to be busy when too many active calls come through at once or when Call Acceptance or Call Rejection is in use.

Call Forwarding - Busy settings are superseded by Call Forwarding – Selective Call Acceptance and Call Rejection (if their selective criteria are set).

Note: If enabled, the Intercept Announcement feature takes precedence over all other active features. For details, see [Intercept Announcement](#).


Forwarded callers are treated according to the forward-to phone number's settings. For example, if the forwarded call isn't answered, callers may be prompted to leave voicemail for the forwarded phone number, not for the first phone number.

To set Call Forwarding – Busy

Manage Inbound User Call Features—Call Forwarding - No Answer

The Call Forwarding – No Answer feature enables a user to redirect calls to another phone number when an incoming call isn't answered within a specified number of rings. (Each ring cycle lasts 6 seconds.) You must specify the forward-to number and the number of rings before forwarding.

Call Forwarding - No Answer settings are superseded by these features (if they're enabled): Call Forwarding - Selective, Call Acceptance, and Call Rejection.

If Call Forwarding - Not Reachable is set for this user, and the Call Forwarding - Not Reachable timer expires before the specified number of rings for Call Forward - No Answer have played, then the Call Forward - Not Reachable settings are applied.

Note: If enabled, the Intercept Announcement feature takes precedence over all other active features. For details, see [Intercept Announcement](#).


Forwarded callers are treated according to the forward-to phone number's settings. For example, if the forwarded call isn't answered, callers may be prompted to leave voicemail for the forwarded phone number, not for the first phone number.

To set Call Forwarding – No Answer

Manage Inbound User Call Features—Call Forwarding - Not Reachable

The Call Forwarding – Not Reachable feature enables a user to set an alternate phone number (for example, a wireless number) where calls will be redirected when the user's AT&T IP Flexible Reach phone number is unreachable.

These features take precedence over Call Forwarding - Not Reachable (if they're active): Simultaneous Ring, Sequential Ring, Call Forwarding - Selective Call Acceptance, and Call Rejection.

Call Forwarding - Not Reachable is also invoked if:

- The Call Forwarding - Not Reachable timer expires before the specified number of rings for Call Forward - No Answer have played.
- A caller routed to Simultaneous Ring presses # to skip the search sequence.

Forwarded calls are treated according to the forward-to phone number's settings. For example, if the forwarded call isn't answered, callers may be prompted to leave voicemail for the forwarded phone number, not for the phone number originally called.


Note: If enabled, the Intercept Announcement feature takes precedence over all other active features. For details, see [Intercept Announcement](#).

Edit a User's Intercept Announcement Settings

Overview

The Intercept Announcement feature plays a message when a user receives a call. When this setting is turned on, the call is intercepted and the specified messages are played to the caller. Use these announcements to provide call routing options along with other useful information.

Use Intercept Announcement

Intercept Announcement gives enterprises the ability to give callers useful information. The default announcement informs callers that the number they've called is out of service. Intercept Announcement can also give callers the user's new phone number and enable users to press 0 to be transferred to a new number that you determine. As an Enterprise Administrator for the AT&T IP Flexible Reach Customer Portal, you can also record and upload custom announcements.

Note: When Intercept Announcement is turned on, users in the group cannot make outbound calls. Emergency calls and calls to other users in this enterprise are still allowed.

Edit a User's Intercept Announcement Settings

You can edit the intercept announcement settings for any user in your group.

Note: When you change the settings for a group, you change the settings for every group user who doesn't have custom intercept announcement settings. User-level settings override group-level settings.

To edit a user's intercept announcement settings

1. From any page in the Customer Portal, click **USER MANAGEMENT** in the main menu bar. The [User List page](#) appears.
2. Click a user's name. The [User Details page](#) appears.
3. Click the **Inbound Features** tab. The Inbound Features List view of the User Details page appears.

- To play a custom recorded announcement, select **Custom**. To upload a new custom announcement, click **Upload New**.
8. Select more options.
 - To play an additional announcement that provides callers with an alternate phone number, to the right of **Announcement Options**, select **Play new phone number** and enter the new phone number in the text box.
 - To play an announcement that prompts callers to press **0** if they want to be transferred, to the right of **Announcement Options**, select **Transfer on '0' to phone number**. In the text box, enter the phone number where the call will be transferred.
 9. To save your edits, click **Save**. To discard your changes, click **Cancel**. To return to the main Settings page, at the top of the Profile view page, click **Back to all Settings**.



Manage Inbound User Call Features—Max DID Policing


The Max DID Policing feature enables the organization to limit the number of concurrent calls that come in to a specific phone number.

Set Sequential Ring

The Sequential Ring feature enables a user to define a "find-me" list of phone numbers that ring sequentially when incoming calls match specified criteria. (For example, if the user can't be reached at the first number, the service tries the second number. If the user can't be reached at the second number, the service tries the third number, and so on.) The caller hears a greeting, followed by periodic announcements.

Users can set Sequential Ring to ring up to five numbers in a specified order.

Note: A user can't use Sequential Ring and Simultaneous Ring at the same time. If both features are set to **Enabled**, Sequential Ring takes precedence.

(If enabled, the Intercept Announcement feature takes precedence over all other active features and selective criteria. For details, see [Intercept Announcement](#).)

You can add up to 12 numbers.

Numbers can be up to 20 digits long, and no phone number format validation is enforced. For public numbers in the North American Numbering Plan, you must enter 10 digits without domestic prefix or country code.

International numbers entries are allowed and must start with **+** or **011**.

You can't block numbers from within your enterprise.

Extensions aren't allowed.

Wildcard characters are allowed:

- An asterisk (*) matches any sequence of digits. You can use an asterisk only at the end of a number entry. For example:
 - 732*
 - 8*
- A question mark (?) matches any single digit anywhere within a specific number entry. It can even replace the first digit of the number. For example:
 - ?52*
 - 73232049??

 - **Yes** means that a person must answer the phone to end the call forwarding sequence.
 - **No** means voicemail can answer and end the sequence.

Note: To add numbers, you must be in Edit mode.

- A question mark (?) matches any single digit anywhere within a Specific Number entry. It can even replace the first digit of the number. For example:

 - 73232049??

Overview

A feature access code (FAC) is the key sequence you press on a phone to enable or disable a feature. For example, if Anonymous Call Rejection Activation is set to *77, you presses ***77** on the phone to activate that feature.

Feature access codes are also called star (*) and pound (#) codes.

Many of the FAC codes activate inbound call features, such as Call Forwarding Always and Call Forwarding Busy. Some are used with outbound call features, such as Per Call Account Codes. Other FAC codes, such as Customer Originated Trace and feature interrogation codes, have no AT&T IP Flexible Reach Customer Portal equivalents.

A set of default FAC codes exist for every group. As an Enterprise Administrator for the AT&T IP Flexible Reach Customer Portal, you can view and edit the values for any of the FAC codes within a group.

Each FAC code must have a Main value. You can also add an Alternate value that the user can enter to enable or disable the feature.

You can also download a list of FAC codes for your group.

The following table details available feature access codes (FACs) and how they work. As an Enterprise Administrator for the Customer Portal, you can edit the FAC code values.

The Intercept Announcement feature plays a message when a user receives a call. When this setting is turned on, the call is intercepted and the specified messages are played to the caller. Use these announcements to provide call routing options along with other useful information.

Use Intercept Announcement

Intercept Announcement gives enterprises the ability to give callers useful information. The default announcement informs callers that the number they've called is out of service. Intercept Announcement can also give callers the user's new phone number and enable users to press **0** to be transferred to a new number that you determine. As an Enterprise Administrator for the AT&T IP Flexible Reach Customer Portal, you can also record and upload custom announcements.

Note: When Intercept Announcement is turned on, users in the group cannot make outbound calls. Emergency calls and calls to other users in this enterprise are still allowed.

Edit a Group's Intercept Announcement Settings

Note: When you change the settings for a group, you change the settings for every group user who doesn't have custom Intercept Announcement settings. User-level settings override group-level settings.

To edit a group's Intercept Announcement settings

2. Click the **Settings** tab. The Settings view of the Group Details page appears.

- To play an announcement that prompts callers to press **0** if they want to be transferred, to the right of **Announcement Options**, select **Transfer on '0' to phone number**. In the text box, enter the phone number where the call will be transferred.

To save your edits, click **Save**. To discard your changes, click **Cancel**. To return to the main Settings page, at the top of the Profile view page, click **Back to all Settings**.

You can assign users to a department, which is a subdivision of a group or enterprise. An Enterprise Department can include any user in the enterprise. A Group Department can include only users from a single group.

A department has:

- A unique department name.
- A set of users assigned to the department.
- A set of public phone number ranges.

You can:

- Search for departments by name.
- Manage department profiles, including editing department names.
- Assign users to the department.
- Unassign (remove) users from the department.
- Download a list of the department names for all the departments you manage.
- Download a list of all the users in a particular department.
- Download a list of all the department public phone number ranges.
- Manage individual users in a department.



Create a Department

As an Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can create departments to group users in smaller groups in the enterprise. (For more information, see [About Departments](#).)

To create a new department

Overview

In an AT&T IP Flexible Reach enterprise, trunk call routing provides the intelligence that routes calls to one or more group trunk groups according to the scheme an Enterprise Administrator sets (for example, routing calls between two customer service sites). The Enterprise Administrator sets trunk call routing scheme properties that determine how a call is handled. The trunk call routing scheme then routes an incoming call between group trunk groups according to the properties selected.

As an IP Flexible Reach Group Administrator, you can view a group trunk group's associated trunk call routing scheme within the AT&T IP Flexible Reach Customer Portal.

Note: As a Group Administrator, you cannot edit trunk call routing schemes. The ability to view a trunk call routing scheme is permission-based. You may or may not have permission to view trunk call routing schemes within your enterprise, based on how your enterprise was set up. You've been granted one of the following permission levels:

- **View Only**—You can view but not edit trunk call routing schemes.
- **Hidden**—You can't view trunk call routing schemes.

Routing Algorithms

An Enterprise Administrator can specify the order in which calls are sent down the various routes and how to respond when one route is operating at maximum capacity and others aren't.

The rules that Enterprise Administrators apply are called routing algorithms. When setting up trunk call routing schemes, they can choose from these four algorithms:

- **Linear**
- **Round Robin**
- **% Allocation**
- **Most Idle**

Linear

The most basic routing algorithm is the Linear algorithm.

Enterprise Administrators use the Linear algorithm to set the order in which group trunk groups receive traffic. If the first group trunk group isn't available or has reached its capacity for concurrent calls, the traffic is routed to the next group trunk group in the trunk call routing scheme. When that group trunk group reaches capacity, traffic shifts to the next group trunk group, and so on, in the order specified by the Enterprise Administrator.

The first group trunk group in the order is created by default when AT&T sets up your service. The search then follows the order in which the Enterprise Administrator adds group trunk groups to the



trunk call routing scheme. To change the search order, the Enterprise Administrator must create a new trunk call routing scheme.

Linear Scenario

An enterprise has two sites and wants to route all Site 1's incoming calls to Site 2 if Site 1 fails. The Enterprise Administrator sets up a Linear scheme for the two sites. A call comes into Site 1, which is unable to handle the call, so it's routed to Site 2.

Round Robin

The Enterprise Administrator uses the Round Robin routing algorithm to spread incoming calls evenly across the group trunk groups.

Like the Linear algorithm, the Round Robin algorithm selects resources in sequence, but the Round Robin algorithm has an added feature: Instead of waiting for one group trunk group to reach capacity before it directs calls to the next, the Round Robin algorithm balances the call volume evenly across all group trunk groups.

Round Robin Scenario

A company has two Boston sites. Boston1 and Boston2 serve the company's full U.S. enterprise. The Enterprise Administrator sets up a Round Robin scheme that pushes the first call to Boston1, the second to Boston2, the third call to Boston1, and the fourth call to Boston2, and so on, alternating between the two to deliver calls continuously.

% Allocation

With the % Allocation algorithm, Enterprise Administrators can assign a percentage of the incoming calls to each group trunk group in the trunk call routing scheme.

The % Allocation algorithm then routes calls to each group trunk group according to the percentages. If a selected group trunk group isn't available or is at maximum capacity, AT&T IP Flexible Reach selects the next group trunk group based on the percentage of allocation of the remaining available group trunk groups.

If a group trunk group is removed from a % Allocation routing scheme, IP Flexible Reach redistributes its percentage over the remaining group trunk groups in the scheme.

% Allocation Scenario

A company has two call centers: Call Center 1 is a small call center and Call Center 2 is a large call center. the Enterprise Administrator wants to route 10% of the call volume to Call Center 1 and 90% of the call volume to Call Center 2.

First, the Enterprise Administrator creates a new trunk call routing scheme with % Allocation routing algorithm, and then assigns the group trunk groups for Call Center 1 and Call Center 2. The percentages are assigned 10% to Call Center 1 and 90% to Call Center 2. The sum of allocations must always equal 100%.



Most Idle

With the Most Idle algorithm, calls are routed to the least used group trunk group at any given time. Like the other algorithms, the Most Idle algorithm offers failover rerouting that's triggered when the first group trunk group in the trunk call routing scheme is unavailable or at maximum capacity.

Most Idle schemes are useful if an Enterprise Administrator wants to balance active call traffic across SIP trunks. The Most Idle algorithm counts active calls, and then sends a new call to the trunk with the fewest active calls.

The Most Idle algorithm assumes that there will never be a time when all trunk groups are running at, or near, capacity.

Most Idle Scenario

In an enterprise using AT&T IP Flexible Reach, a part of the enterprise served by Call Center 1 is having a town hall meeting, so Call Center 1 is very busy. Call Center 2, which serves the rest of the enterprise, is not busy. To let Call Center 2 help with the heavy call traffic, the Enterprise Administrator sets up a Most Idle scheme. Call Center 2 will pick up overflow traffic.

About Group Trunk Groups

Trunking is a concept that describes how a communications system provides network access to many users by sharing a set of lines or frequencies, instead of providing the lines or frequencies individually. A trunk is a single transmission channel between two points, one point being the switching center and one the node.

The term trunk refers to the structure of the system, which can be compared to a tree with one trunk and many branches.

A group trunk group is the path that a call takes between AT&T IP Flexible Reach and your organization's PBX (private branch exchange), and ultimately the user.

The group trunk group has a set maximum number of calls, incoming and outgoing, that it can handle simultaneously.

A trunk call routing scheme enables you to:

- Bundle one or more group trunk groups and assign the bundled group trunk group an identity.
- Place rules on that identity that select which one of the bundled group trunk groups receives an incoming call.

When you create a group, IP Flexible Reach creates a single group trunk group and adds it to a trunk call routing scheme created for that group. You can then add other group trunk groups to that trunk call routing scheme.

As part of managing group trunk groups in your role as a Group Administrator for the IP Flexible Reach Customer Portal, you can edit your group trunk group profile.

About Schedules and Events

When setting the features **Simultaneous Ring**, **Sequential Ring**, **Call Acceptance**, **Call forwarding – Selective**, and **Call Rejection**, users and administrators use schedules with criteria that define how and when these features will be applied to incoming calls. You can save schedules and apply them to other criteria at any time.

As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can create schedules at the user level for a single user and at the group level for your group. (Enterprise Administrators can create enterprise-, group-, and user-level schedules. Users can create schedules only for themselves, at the user level.)

A schedule consists of one or more events. Each event has a time, date, and recurrence option. An event can be for a specific time, a single day, or a range of days. An event can occur once, or you can set it to recur multiple times. An event can recur at regular intervals (for example, every second Monday of the month for six months) or for a set time with no set end date (for example, every Thursday from 1 to 2 a.m.).

You can add, edit, and delete events within a schedule.

IP Flexible Reach has two types of schedules: Holiday and Time. Use Holiday schedules for holidays and other non-working events, such as company picnics or personal vacations. Use Time schedules when scheduling any other type of event.

For example, a Holiday schedule named Company Holidays might include separate events for each holiday of the year: New Year's Day, Presidents' Day, Memorial Day, 4th of July, Labor Day, and so on. You might also create a user Time schedule named Work Hours that includes the recurring event of your Monday through Friday regular work hours.

5. To the right of the schedule name, under **Actions**, click the Delete icon . A Confirm Delete window opens.

Caution: You cannot recover a deleted schedule.

6. Click **Save**. The schedule is deleted and no longer appears on the Schedule List page.

You can create events for a new schedule, or you can create new events for an existing schedule. (As a Group Administrator, you can create events for group- or user-level schedules. Enterprise Administrators create events for enterprise-level schedules.) Schedules provide the time frame for selective criteria used with the **Sequential Ring**, **Simultaneous Ring**, **Call Acceptance**, **Call Rejection**, and **Call Forwarding – Selective** features.

Every schedule must have one or more events, which define the days and times when the schedule is actively in effect. Each event has its own initial start time and end time, and each event can occur one time or repeat.

Whenever an event's specified time period (and recurrence pattern, if selected) matches the current calendar date and time, the schedule containing this event takes effect and affects all the features to which the schedule has been applied.

Create an Event for a New Schedule




You can create events immediately after creating a new schedule.

The **Initial Event Details** settings specify the duration of the first complete occurrence of the event.


- Initial start and end dates specify the dates of one complete occurrence.
- Start and end times specify the hours in which the event occurs.

Event Recurrence specifies how frequently the **Initial Event Details** are repeated: daily, weekly, monthly, or yearly. You can also specify recurrence intervals, such as every 5 days or every 2 weeks. You can set a recurrence pattern to stop on a specific date, after a set number of occurrences, or not at all.


To create an event for a new schedule

1. If you've just [created a new schedule](#), a message confirms that your schedule was created successfully. Click the schedule name or the Edit icon . The [Schedule Details](#) page appears.
2. Click  **Add Event**. The Add Event page appears.
3. Under **Initial Event Details**, enter details for the initial event, which becomes the template for any recurrence of the event.
 - Enter the event name.
 - Enter a start and an end date in MM/DD/YYYY format, or click the Calendar icon  and select dates.
 - Enter a start and an end time.
4. Under **Event Recurrence Details**, set how often the event will recur. From the **Recurrence** list, select **None**, **Daily**, **Weekly**, **Monthly**, or **Yearly**.



5. The recurrence details vary, depending on whether you selected **None**, **Daily**, **Weekly**, **Monthly**, or **Yearly**. Follow these steps:
 - If you selected **None**, skip to step 7 (click **Add**).
 - If you selected **Daily**, in the **Recurs every (x) days** field, enter a number from 1 through 6. For an event that recurs every day, enter 1, for an event that recurs every two days, enter 2, and so on.
 - If you selected **Weekly**:
 - In the **Recurs every (x) week(s) on** field, enter a number.
 - Check **Mon-Fri** or a specific day of the week.
 - If you selected **Monthly**:
 - In the **Recurs every (x) month(s) on** field, enter a number, and then do one of these things:
 - Select **Day (x) of the month** and enter the day of the month you want.
 - Select **The (number) (weekday) of the month** and, from the lists, select the number and day of the week you want.
 - If you selected **Yearly**:
 - In the **Recurs every (x) year(s) on** field, enter a number, and then do one of these things:
 - Select **Day (x) of (month)**, enter the day, and then select the month you want.
 - Select **The (number) (weekday) of (month)**, and then, from the lists, select the number, weekday, and month you want.
6. If you selected **Daily**, **Weekly**, **Monthly**, or **Yearly**, now decide whether to set an end for the recurrence:
 - To set no end date, leave **Recurrence End** set to **Never**.
 - To set the recurrence to end after a certain number of times, in the **After (x) occurrence(s)** field, enter a number.
 - To set a specific end date, enter the date in MM/DD/YYYY format, or click the Calendar icon  and select a date.

7. Click **Add**.

To create another event in this new schedule, click  **Add Event**, and repeat steps 3 through 7.

 - In the **Recurs every (x) week(s) on** field, enter a number.
 - Check **Mon-Fri** or a specific day of the week.
 - If you selected **Monthly**:
 - In the **Recurs every (x) month(s) on** field, enter a number, and then do one of these things:
 - Select **Day (x) of the month** and enter the day of the month you want.
 - Select **The (number) (weekday) of the month** and, from the lists, select the number and day of the week you want.
 - If you selected **Yearly**:
 - In the **Recurs every (x) year(s) on** field, enter a number, and then do one of these things:
 - Select **Day (x) of (month)**, enter the day, and then select the month you want.
 - Select **The (number) (weekday) of (month)**, and then, from the lists, select the number, weekday, and month you want.
8. If you selected **Daily**, **Weekly**, **Monthly**, or **Yearly**, now decide whether to set an end for the recurrence.
 - To set no end date, leave **Recurrence End** set to **Never**.



- To set the recurrence to end after a certain number of times, in the **After (x) occurrence(s)** field, enter a number.
- To select a specific end date, enter the date in MM/DD/YYYY format, or click the Calendar icon  and select a date.

9. Click **Add**.

To create another event in this schedule, click  **Add Event**, and repeat steps 5 through 9.

Examples

These examples show you how to set typical events.

A one-time holiday (for example, the first day of school)

- **Same** initial start and end date.
- All day event checked.
- Recurrence set to **Never**.

An annual holiday (for example, New Year's Day)

- **Both** the initial start and end dates set to 1/1/2014.

- Recurrence set to **Yearly**.

Your work week

- Initial start date is a specific **Monday**.
- Initial end date is the **same Monday**.
- Start time is **8:00 a.m.**, end time is **5:00 p.m.**
- Recurrence pattern is set to **Weekly**.
- Recurs every **1** week. Check **Mon-Fri** and each individual day **Monday, Tuesday, Wednesday, Thursday, and Friday**.
- Recurrence pattern ends **Never**.

About Account Codes

As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can create and use account codes to track certain calls associated with specific accounts. Account codes help you track the calls users make outside your group. You create account codes at the group level and then assign an account code status to users. You can assign an account code status to users in bulk, or you can assign account code status to users individually.

If you assign an account code status to users, inform the users which account codes they must use for which phone numbers.

IP Flexible Reach has two kinds of account codes: mandatory and optional.

- Users assigned to the Mandatory Account Code service must enter an account code when making all calls outside their group.
- Users assigned to the Optional Account Code service can enter an account code when making a call outside their group, but it's not required.

When you assign an account code status to users, be sure to tell the users which account codes they must use for which phone numbers. To be validated, the account code only has to meet the group's account code length requirement; it doesn't have to match any of the codes provisioned for the group.

Account codes aren't required for call transfers and forwards. Users assigned mandatory account code status can transfer and forward calls without being prompted to enter an account code (including when using advanced forwarding options such as Simultaneous Ring and Sequential Ring).

As a Group Administrator, you can:

- Add, edit, and delete account codes.
- Download a list of account codes for a particular group.
- Download a list of the users assigned a group's mandatory or optional account code status.
- Assign and unassign mandatory or optional account code status to users.
- Edit the default account code length for a group.


Caution: Changing the length of an account code setting causes all current account codes to be deleted.




Search for and View Account Codes

Within the group you manage, you can search for and view specific account codes, and then edit or delete them.

To search for and view account codes

About Authorization Codes

Authorization codes help you manage outbound calling. As a Group Administrator for the AT&T IP Flexible Reach Customer Portal, you can create authorization codes for different types of outgoing calls. If you've provisioned authorization codes for a group, you can require users to enter an authorization code when making calls (except for emergency or repair calls) outside the group.

The user is prompted to enter the authorization code. The user then enters the authorization code followed by the pound sign (#). If the code entered is valid, the user hears a confirmation announcement and the call proceeds. The system captures the valid authorization code entered by the user in the accounting information (Call Detail Record) generated for that call.





Search for Authorization Codes

You can search for a specific authorization code within your group. When you find the authorization code you're looking for, you can edit or delete it.

Using dial restrictions, you can block users from making certain types of calls, such as calls to international or toll-free numbers. You can also use dial restrictions to require users to enter an authorization code for certain types of outgoing calls.

You can use dial restrictions with these types of calls:

- Intra-enterprise
- Domestic
- Toll-free
- International
- Operator assisted
- Directory Assistance

Inventory Reports

Inventory reports provide details about your group and departments.

User Inventory Report

A User Inventory report summarizes the settings for each assigned user, including:

- User public telephone number (if applicable).
- Private number (if applicable).
- User first and last name.
- Group name and ID.
- Group private phone number.
- Trunk call routing assignment name.
- User dial restrictions: **Group** or **Custom**.
- User Premier access: **Eligible** or **Ineligible**.
- Max DID Policing value.
- Inbound call features. The report shows only features that are enabled or disabled (made available) for each user.
- Outbound dial plan settings: **Group Default** or **Custom**.

Group Inventory Report

A Group Inventory Report provides details about your group, including:

- Group name.
- Group ID.
- Private branch exchange phone number (PBX TN).
- Number of users in the group.
- Number of group trunk groups associated with the group.
- Default trunk call routing associated with the group.

Group Trunk Group Inventory Report

A Group Trunk Group Inventory Report provides details about one or more group trunk groups, including:

- Group trunk group name.
- Associated group name and ID.
- Maximum number of concurrent calls for the group trunk group (**Group**, **Inbound**, and **Outbound**).
- Bursting status.
- Burst rate (**Total**, **Inbound**, and **Outbound**).
- **Trunk Group Forward Always** setting and target.



- **Trunk Group Unreachable Destination** setting and target.
- **Trunk Group Destination Unreachable** timer.
- Number of assigned trunk call routings.

Feature Configuration Report

A Feature Configuration report provides details about feature usage, including:

- Group name, Group ID, and Department name.
- Inbound and outbound features status (enabled or not enabled).
- Group **Intercept Announcement** status (enabled or not enabled).

Service Usage Reports

Service Usage Reports provide information about your group and departments.

Account Code Summary Report

An Account Code Summary Report provides a list of account codes, plus it gives the total number of hours, minutes, and seconds for calls that used each account code during the specified report period and for other input filters you set.

The Account Code Summary Report includes:

- Account codes used.
- Location ID of users dialing the account codes.
- Corresponding duration of usage during the report interval.

Authorization Code Summary Report

An Authorization Code Summary Report provides a list of authorization codes, plus it gives the total number of hours, minutes, and seconds for calls that used each authorization code during the specified report period and for other input filters you set.

The Authorization Code Summary Report includes:

- Authorization codes used.
- Location ID of users dialing the authorization codes.
- Corresponding seconds of usage during the report interval.

Call Transfer/Forward Report

A Call Transfer/Forward Report summarizes calls transferred and forwarded during the specified report period and for other input filters you set, including:

- Calls transferred/forwarded within your group or within all or specific departments.
- Calls transferred/forwarded to the redirecting party.
- The transfer/forward destination.



Inbound Call Detail Report

An Inbound Call Detail Report summarizes inbound calls received during the specified report period and for other input filters you set, including:

- Inbound calls received by users, a group, or a group trunk group.
- Inbound calls to users' phone numbers.

Outbound Call Detail Report

An Outbound Call Detail report summarizes outbound calls made during the specified report period and for other input filters you set, including:

- Outbound calls originating from your group or from all or specific departments.
- Outbound calls originating from phone numbers.
- Outbound call destination.
- Authorization code and account code information, if applicable.
